



### **RAFT RENTAL AGREEMENT**

- 1. Life raft rentals:** Are Charged for the daily “possession” of the raft rented to you. The rental rate is based on the size and type of the raft you select. You are not charged for the shipping transit time to or from your location. You are responsible to return the raft in the same condition that you received it. Shipping cost is not included in your rental cost, however it can be added at the time of rental. You have the option to add insurance for theft or loss in transit for the returned portion of your rental. (See paragraph #4 for more info)
- 2. Use of raft:** If for any reason you activate the raft, for “real” or by accident, the raft is not returnable, and you will be charged the replacement cost of the raft. Rafts vary in replacement costs but can cost \$2500 or more depending on the model and age of the raft. In the event of a documented emergency use, Winslow may replace the raft at no charge.
- 3. Tampering with the raft contents:** All rafts rented have been designed for the rental use of the raft. All rafts are Vacuum Packed by Winslow and covered in a valise. Any attempt to unpack, enter, or cut open the raft or its valise will void the rental agreement and the raft’s integrity and you will be charged the cost to replace the raft.
- 4. Failure to return the raft:** Rafts that are 10 days overdue from a scheduled rental will be charged for the value of the raft. Please keep your tracking number handy in

case the raft is lost in transit. IT IS YOUR RESPONSIBILITY TO RETURN YOUR RAFT AS SCHEDULED, FBO'S, MARINAS AND "PACK AND MAIL" FACILITIES ARE NOT RESPONSIBLE. YOU NEED TO PHYSICALLY HAND IT TO A FED EX "OWNED" FACILITY, OR A FED EX DRIVER! **The renter is responsible for the raft until it is delivered back to our facilities in the same manner as it was received.**

5. **Pick up or drop off:** We work with several FBO's in Melbourne Florida. Please let us know if you intend to pick up or drop off a raft at an airport. Rental rates differ for pick up/drop off.
6. **Shipping:** All rafts are shipped in a Pelican Case to protect the raft during shipping. When returning the raft, ensure that the case is sealed and returned with the raft. Damage to the Pelican case while in transit is not held against you, but please notify us so we may claim the damage against the shipper.
7. **Express shipping:** All rafts are shipped using FedEx Ground. While you are not charged for transit time, you are charged for standard shipping costs. If your request is short notice, AS IN SAME DAY PROCESSING requiring shipment by air, a \$100.00 handling fee will be added to the shipping cost. Express shipping requires special handling and a lot paperwork.
8. **Late return costs:** Returns of the raft beyond the rental agreement are charged at the same day rate as the original daily rental rate. If you are going to be late with a return, please call or email us.
9. **PLB's and life vests:** We offer life vest and PLB rentals. These are charged as a flat rate with your raft rental. If you require a PLB, please fill out the PLB Form as we

need your information in the event you activate the PLB. For a life vest, please call us and let us know how many and what type.

10. **Minimum:** There is a 4 day minimum for any raft rental if a raft needs to be shipped. Pick-up and drop off at our facility has no minimum rental .

11. **Attorneys Fees.** In the event that any suit or action is instituted under or in relation to this Agreement, including without limitation to enforce any provision in this Agreement, the prevailing party in such dispute shall be entitled to recover from the losing party all fees, costs and expenses of enforcing any right of such prevailing party under or with respect to this Agreement, including without limitation, such reasonable fees and expenses of attorneys and accountants, which shall include, without limitation, all fees, costs and expenses of appeals.

Please complete documents and either fax or email back to us. Please call or email to verify that we have received your rental request. Failure to confirm rental may cause a delay in the process.
